CURRENT FINANCIAL YEAR 2020-21**

A meeting on the subject was held under the chairmanship of the Special Secretary to Chief Minister Khyber Pakhtunkhwa on 22-01-2021 at 11:30 AM in Chief Minister's Secretariat, Peshawar.

2. The chair welcomed the members and the meeting started with the recitation of the Holy Quran.

3. Reference is made to procurement committee meeting dated 08-01-2021 wherein it was decided to solicit advice of KPPRA regarding joint ventures between the firms. The said advice has been received and accordingly laid down before the committee. The KPPRA letter states "if joint ventures have been allowed in the bid solicitation documents of the procuring entity only then the joint ventures shall be considered for evaluation otherwise not". Therefore, the procurement committee checked the bids of the below mentioned firms and decided as under: -






5. The procurement committee recommends the following for the approval of Competent Authority: -


- To approve the proceedings of committee for the procurement of telephone exchange from **M/s Insiyabi Pvt, Pakistan**.
